Who is responsible for processing the data?

How have we obtained your personal data?

We have obtained your personal data through your previous or current relationship with our association. This data is provided directly by you when you fill in the forms provided by ADELANTE ÁFRICA for this purpose. This may be as a result of your status as a member or donor or through your participation in our activities.

What personal data do we process?

ADELANTE ÁFRICA processes the following data:

- Name and surname
- ID number
- Email address
- Telephone number
- Address and post code
- Bank account number (if you have direct debits)
- Amount donated

The purpose of personal data processing:

- To comply with the association's legal and tax requirements
- To handle the mailing of information and documentation regarding ADELANTE ÁFRICA, including via electronic means and even after our relationship with you has terminated, unless you inform us to the contrary.
- To handle your inquiries, requests, comments and suggestions
- To invite you to functions and events organised by ADELANTE ÁFRICA

Why can we process your personal data?

The processing of your personal data with regards to maintaining your relationship with ADELANTE ÁFRICA as a member, supporter or sponsor, is lawful and necessary in order to fulfil the contractual obligations derived from this relationship.

The processing of your personal data in order to send promotional material regarding ADELANTE ÁFRICA's activities, campaigns or initiatives, similar to those in which you have participated, meets a legitimate interest and is authorised by the regulations currently in force.

When and for what reason can we pass your data to third parties?

ADELANTE ÁFRICA does not pass personal data to any third party, except to those listed below, for the reasons indicated:

- Public Administration, to comply with the legal and tax requirements to which ADELANTE ÁFRICA is subject as a result of our activity.
- Third parties considered necessary in order to fulfil the obligations derived from campaigns, activities and initiatives in which you voluntarily participate.

If, in the future, ADELANTE ÁFRICA passes on any personal data, we shall inform you at the time.

Under no circumstances will ADELANTE ÁFRICA pass on or sell data from its digital or paper forms to third parties.

Do we carry out international transfer of data?

ADELANTE ÁFRICA does not carry out any international transfer of the data it collects.

How long do we keep your data for?

Your personal data will be kept as long as you maintain your relationship with ADELANTE ÁFRICA, and after the termination of this relationship for any reason, during the legally prescribed period in order to comply with our legal or contractual obligations. Once the prescribed period is over, your data will be removed or alternatively made anonymous.

What are your rights?

You may exercise your rights of personal data access, correction, removal, transfer, opposition and limitation by sending a letter to ADELANTE ÁFRICA or by emailing us at info@adelanteafrica.org

Equally, if you consider that the processing of your personal data violates the current regulations or your privacy rights, you may make a complaint to either of the following:
